

## **The below Amendments supersede the ones in the 2017 Members Handbook**

### **Bylaw Amendments made in 2019 and 2022**

#### **Article 2 Membership**

##### **Paragraph 4**

- **New members must attend the range orientation conducted by a club Chief Range Safety Officer or the appointed assistants. Applicants must Sign an acknowledgment form confirming that they have received, read and understand the provided copy of the Range Rules and Club Bylaws before receiving their membership card and being allowed to use the ranges.**

##### **Paragraph 5**

- **Membership includes immediate family members that are living in the same household. When using the Club Facilities, family members must be accompanied by the Membership Card holding Member who is responsible for their conduct at all times. Family members may not vote at any of the regular Membership Meetings.**

##### **Paragraph 6**

- ~~**Membership in good standing requires the attendance at three meetings & three workdays per year or be assessed \$15.00 for each meeting/workday missed payable with their annual dues.**~~

This Paragraph has been deleted from the Bylaws.

#### **Article 3 Dues**

##### **Paragraph 1**

- **The Annual Membership Dues shall be \$100.00 and is payable not later than the regular August Meeting of each Year. Any Member failing to renew by the August deadline will lose his/her Membership subject to an Executive Board review.**

##### **Paragraph 2**

- **The New Member Initiation Fee and/or the Reinstatement of a Member dropped from the Club's Rolls is \$100.00. The Initiation Fee shall be waived for active duty Military and Sworn Law Enforcement Personnel. Any Active Duty Military Personal while Deployed overseas will Retain/Keep their General Club Membership and shall report to the Club within 60 Days of their Return.**

#### **Article 4 Meetings**

**All meetings shall be conducted under the current Robert's Rules of Order**

##### **Paragraph 1**

- **The purpose of the Annual Meeting is to elect the Executive Committee. The Annual Club Meeting shall be held on the first Tuesday of September each Year at 7 PM at the Club Facilities (Year is defined as September 1<sup>st</sup> thru August 31<sup>st</sup>). If the Annual Meeting cannot take place at the time fixed it shall be held within a reasonable time not to exceed 30 Days.**

##### **Paragraph 2**

- **The Regular Meeting of the Club for conducting ordinary business shall be held on the first Tuesday of each Month at 7 PM unless canceled due to inclement Weather or Holiday.**

Paragraph 3

- **A Special Meeting of the Club may be held at any time upon the call of the Executive Committee or the Board of Directors. A Special Meeting of the Club may be called by a request in writing from any member stating the subject of the proposed meeting and signed by not less than 10 Club Members. Notice of the time, place and reason of any Special Meeting shall be given to all club members by the Club's Website or E-Mail not less than ten days prior to the date of the Special Meeting. The place And Date of this Special Meeting shall be designated by the Club's Executive Committee.**

Paragraph 4

- **A minimum of 20 members shall constitute a Quorum at any General Membership or Special Meetings. A required quorum of at least 3 Executive Committee members or Board of Director Members be present at their meeting to conduct any Club business. A majority of 51% of the General Membership (members) present is required to pass any motions.**
